Under direction to perform maintenance of MST's rolling stock to insure continued safe operation.

ESSENTIAL FUNCTIONS

Removes, replaces, repairs and adjusts all components and parts without supervision. Repairs all components and parts under supervision; other maintenance duties as required.

KNOWLEDGE & ABILITY

Ability to follow written and verbal instructions; ability to qualify for Class B license; familiarity with all phases of vehicle maintenance with emphasis on **heavy duty diesel experience**; familiarity with MST service area; ability to perform required duties.

MINIMUM QUALIFICATIONS & REQUIREMENTS

Graduation from high school or GED equivalent; previous bus driving experience helpful but not required. **Excellent driving record**; licensed driver for 5 years; must possess valid California driver's license at time of application and meet all qualifications specified by the State of California for a Class B Drivers License; In accordance with the Immigration Reform and Control Act of 1986, must be prepared to offer documents to support employment eligibility; willingness to work outside.

If hired, must pass a post offer pre-employment drug screening and DMV required physical examination; must pass vehicle controls test; obtain a Class B **instruction permit** with air-brakes certification, **or** possess a valid Class B license, participate in random drug and alcohol testing as mandated by the Department of Transportation and join Local 1225 of Amalgamated Transit Union.
